A personal tribute to Senator Joe Hogan-29280

I am deeply saddened by the news of Senator Joe Hogan's passing and I never ever met the man. But back in 2009 Joe grabbed a dream of mine and made it happen. I will be forever grateful. It was my hope back then that the Canada JCI Senate could be more than just a social network from days gone by. Personally I felt that we as Senators could and should be more relevant.

I remember searching the JCI website for something that could be attractive to Senators and that might also help build a bridge between Senators and JCI Canada. I came across Bed Nets. In my view Bed Nets was perfect. It was a global outreach program of JCI and I felt that if the Canada JCI Senate could get involved and show some leadership it would be well received by JCI Canada. Maybe they would be encouraged to join us in that campaign. I was also (and still am) passionate about the beauty and power of the Jaycee Creed. Bed Nets was perfectly aligned with the first and last tenet. And who could not feel good about saving lives in a faraway country. I did not know how to make the dream a reality. All I could do was float the idea by Senators through a newsletter article and hope somehow it would gain some traction.

Well it did, and by one great man. A Senator out of Durham, Senator Joe Hogan 29280 began the discussion with me and over several years Joe never ceased to amaze me with his dedication and determination to make a difference in the world. Joe managed to inspire many people who eventually contributed over 2600 Bed Nets and thus saving well over 10,000 human beings from being infected with Malaria. How great is that?

Thankfully I was able to have some great phone and email communications with Senator Joe along the way. A recent one in March of this year involved the sad reality of child poverty in Canada. Joe was musing about what could be if that became a national program for JCI Canada with we as Senators mentoring and offering support and assistance where invited. How beautiful is that thought? Imagine JCI Canada and the Canada JCI Senate working together through committees, community programs and projects to alleviate child hunger and poverty in our own country. That could make for some really good press and branding for JCI.

To the outgoing and incoming Executives of JCI Canada and the Canada JCI Senate I ask this, "Would you please open dialogue with each other and place on your respective agenda the thought of working together on a national program of significance."

This would be in honour and memory of Senator Joe Hogan 29280, who in this Senator's opinion set the highest example of what a Canada JCI Senator could aspire to. And to my fellow Senators I ask. "Is there some way we can set up an annual bursary or award in honour of Joe with proceeds coming from our foundation?"

Please find enclosed in this newsletter an initial draft of the motions to be presented during the AGM at the Crew Meeting, which deal with the New Directions report's recommendations, proposed changes to the Terms of Reference, etc. At this stage, they are intended to provide a guideline as to how these discussions will be approached in Toronto, and so changes may be proposed to these as our deliberations happen.

We are very fortunate to have current JCI Canada Executive Vice President Shawn McMillan 73147 joining the Friday afternoon discussion at the Crew Meeting to look at how Senators can best help current chapters and members. EVP Shawn will also provide an update on the status of JCI Canada, as well as information on trends in membership globally, and various influences such as technology on JCI today.

I look forward to seeing those of you attending the Crew Meeting in Toronto!

MOTIONS REQUIRED TO IMPLEMENT THE RECOMMENDATIONS OF THE NEW DIRECTIONS COMMITTEE AT THE 2016 ANNUAL MEETING

1. **MOVED HUTCHEON – SECONDED SALMON THAT ANY MEMBER OF THE CANADA JCI SENATE SHALL BE ENTITLED TO VOTE THROUGH THE ELECTRONIC ABSENTEE BALLOT SYSTEM ON CHANGES TO THE TERMS OF REFERENCE; THE APPROVAL OF THE FINANCIAL STATEMENTS, THE ELECTION OF OFFICERS; THE SELECTION OF THE NEXT MEETING OF THE CREW; AND SUCH OTHER MATTERS AS THE CANADA JCI SENATE EXECUTIVE SHALL DEEM APPROPRIATE.**

ONCE THIS MOTION IS APPROVED THE MEETING SHOULD DEAL WITH THE TERMS OF REFERENCE. AFTER THAT IS COMPLETE THE FOLLOWING MOTIONS SHOULD BE DEALT WITH IF THEY ARE STILL APPROPRIATE.

2. **MOVED HUTCHEON – SECONDED SALMON THAT THE ABSENTEE VOTING POLICY BE APPROVED AS CIRCULATED**
3. **MOVED HUTCHEON – SECONDED SALMON THAT THE ABSENTEE VOTING POLICY BE IMPLEMENTED FOR THE 2017 ANNUAL MEETING OF THE CANADA JCI SENATE**

4. MOVED HUTCHEON – SECONDED SALMON THAT THE MEETING RECOMMENDATION BE APPROVED AS CIRCULATED

Meetings:

- An absentee voting mechanism to be implemented by the 2017 business meeting of the Senate, and for each official business meeting of the Senate thereafter.

5. MOVED HUTCHEON – SECONDED SALMON THAT THE COMMUNICATION RECOMMENDATION BE APPROVED AS CIRCULATED

Communications:

- Approve the digital newsletter concept

6. MOVED HUTCHEON – SECONDED SALMON THAT THE PROGRAMMING RECOMMENDATIONS BE APPROVED AS CIRCULATED

Programming:

- Mentorship components realized through programming at the JCI Canada National Convention, and other protocols developed jointly between JCI Canada and the Senate to guide assistance to current and potential local chapters

- Specific mentorship initiatives and protocols to be developed through a half-day “summit” about assisting current JCI chapters, to be added on to the 2016 Crew Meeting agenda
- Individual development components realized through participation in opportunities provided through JCI Canada, at the National Convention or other web-based through year
- Community development components realized through participation in opportunities provided at the JCI Canada National Convention and Senate participation in JCI’s current “global outreach” program (ie. Bed Nets)
- Business development components realized through optional inclusion of business information in a Senate directory listing

7. MOVED HUTCHEON – SECONDED SALMON THAT THE FINANCE RECOMMENDATIONS BE APPROVED AS CIRCULATED

Finance:

- Appoint a task force to develop, over 2016/17, a specific proposal for a possible membership fee, to be presented and discussed at the 2017 business meeting of the Senate (to aid the large proportion of Senators currently “undecided” about a possible membership fee to determine a position so decisions can be made)
- The task force should also develop long-term forecasts, and propose expense-related recommendations for the Senate to ensure its financial sustainability beyond 2025.
- The task force’s examination should address such questions as:
 - What impact would a fixed fee have on the Senate’s revenue?
 - Should we continue to spend a large proportion of the Senate budget on executive travel?
 - In the future can we continue to finance a Meeting of the Crew every year?
 - How should the reserve fund be used, and how should it be held/invested?
 - What other revenue sources could/should be pursued (sponsorships, donations of air miles, etc.)

8. MOVED HUTCHEON – SECONDED SALMON THAT THE POTENTIAL EXPANSION RECOMMENDATION BE APPROVED AS CIRCULATED

Potential Expansion:

- Conduct a survey in early 2016/17 to gauge Senators’ interest in offering a membership option to other JCI alumni who were not granted a Senatorship, Governorship or Maple Leaf. The goal of such expansion would be to increase attendance for the social components of the Senate Meetings and derive new revenues for the Senate from membership/affiliation fees of this group.

9. MOVED HUTCHEON – SECONDED SALMON THAT THE GOVERNANCE RECOMMENDATIONS BE APPROVED AS CIRCULATED

Governance:

- Senate Executive terms to be changed to calendar year, to coincide with JCI Canada National Board terms, to enhance collaboration by avoiding the disruption and loss in momentum that the turnover in offices partway through the year causes.
- The transition would be phased in according to the following timetable:
 - 2016-2017 May 2016 to Sept 2017
 - 2017-2018 Sept 2017 to Dec 2018

This would coincide with the May crew meeting as well as the second annual senate meeting during Canada JCI convention.

10. MOVED HUTCHEON – SECONDED SALMON THAT THE FUTURE DIRECTIONS COMMITTEE’S MANDATE BE CONTINUED FOR ANOTHER YEAR. WITH MATT HUTCHEON AS THE CHAIR. IN ORDER THAT THE COMMITTEE MAY COMPLETE ITS WORK. THE COMMITTEE IS TO REPORT AT THE 2017 ANNUAL MEETING OF THE CANADA JCI SENATE
